- Pursuant to actual requirements of business lines of DHG Pharma,

The Board of Directors (BOD) respectfully submits to the General Meeting of Shareholders:

1. Adding the business lines - Printing and service activities related to printing

Previously, DHG Packaging One Member Co., Ltd. (DHG PP1) was a wholly owned subsidiary of DHG Pharma. DHG PP1 was merged into DHG Pharma to streamline its management and operation in accordance with provisions of laws after the Company lifted its FOL. When merging in 2018, DHG Pharma did not continue to register the business line - services related to printing of DHG PP1 due to restricted business conditions for enterprises with more than 50% of foreign investments.

Currently, due to the business development demand of the Company and legal provisions on market opening for foreign enterprises to provide services related to packaging and printing. Accordingly, the packaging printing business line of DHG 1 Packaging Factory Project will be retrieved under the guidance of the Official Letter No.7415/BCT-DB dated 04 Oct 2019 of the Ministry of Industry and Trade and the Official Letter No. 400/DTNN-NN dated 10 Oct 2019 of the Foreign Investment Agency - Ministry of Planning and Investment. Code of business lines are specified in Section 2.

#### 2. Submission content:

The BOD respectfully submits to the General Meeting of Shareholders to approve the supplemented business lines - Printing and service activities related to printing and

the amendment of the Company's Charter and other regulations related to the printing business line which corresponds to the new supplemented business lines - Printing and service activities related to printing, specifically as follows:
